 The name of the dog and all the details as recorded with the Kennel Club must be given on this entry form.  
 If an error is made the dog may be disqualified by the Committee of the Kennel Club.  
 All dogs must be REGISTERED at the Kennel Club in the name of the competitor.  
 If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries.  
 In case of dispute proof of postage of such applications may be required by the Kennel Club.  
 If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after it's name.  
 Dogs under 12 months of age on the day of the Stake cannot be entered for competition.
